YouthSpeak Forum

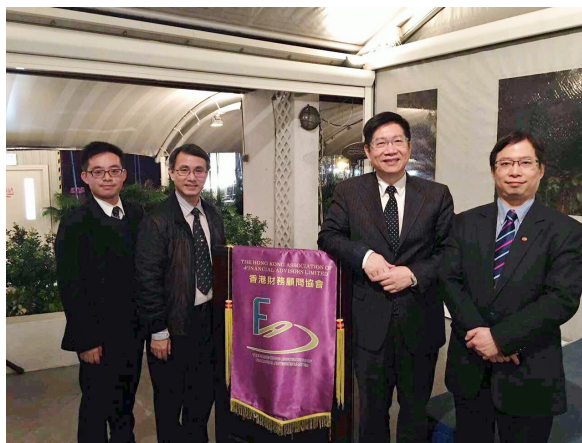

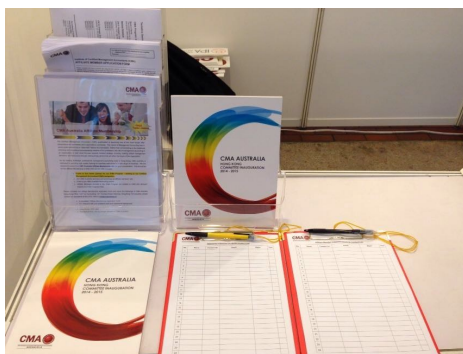

Thursday, 17 March 2016

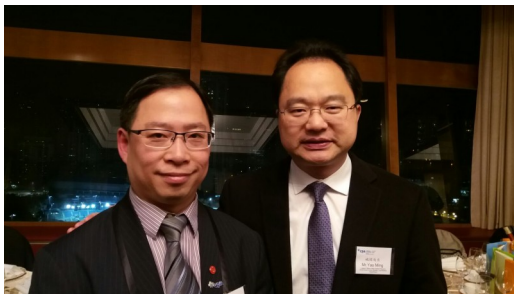
