A Memorandum of Understanding (MOU) is signed with IT Accountants Association, Hong Kong (ITAA) in December 2011.

Full members of ITAA may apply to become a Graduate Management Accountant (GMA) or Certified Management Accountant (CMA) upon fulfilling relevant membership requirements.

At the same time, full members of ICMA Hong Kong may apply to ITAA as full members (no additional exams are required) upon fulfilling the following requirements:

- Hold a recognized degree in Accounting or other related disciplines; and
- Accumulated at least 3 years solid work experience in Accounting, Management, IT or related areas; and
- Complete 2 specified ITAA Continuing Professional Development workshops
